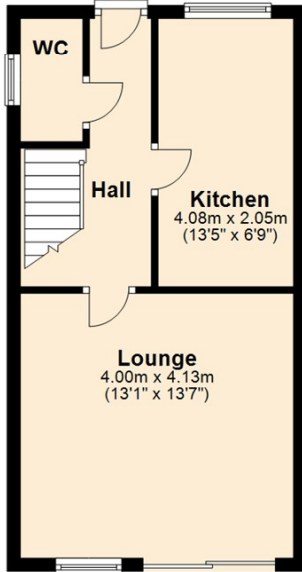

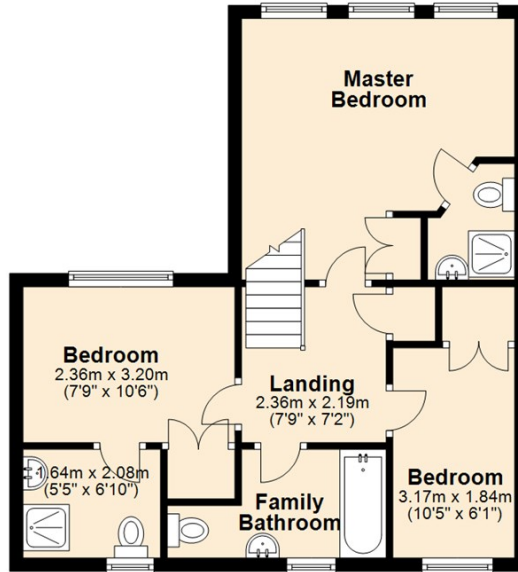

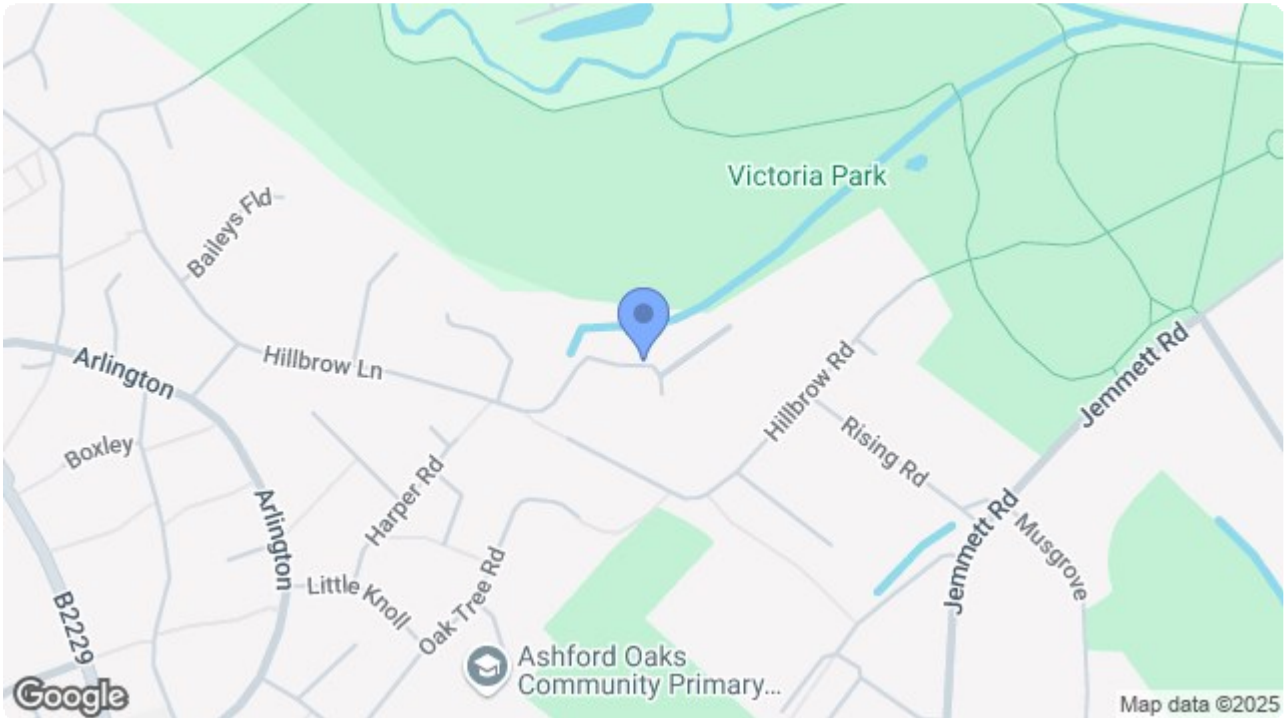


First Floor
